ECO FRIENDLY TOURISM

297. DR. ASHOK KUMAR MITTAL:

Will the Minister of **TOURISM** be pleased to state:

- (a) whether Government has taken any measures to promote sustainable and environment friendly ecotourism projects in various States including Punjab;
- (b) if so, the details thereof;
- (c) whether there is any special project particularly for Jalandhar and Kapurthala districts of Punjab; and
- (d) the details of the activities involved under the said policy and the environment benefits likely to be obtained as a result thereof?

ANSWER

THE MINISTER OF TOURISM

(SHRI G. KISHAN REDDY)

(a) to (d): To develop an enabling ecosystem for the growth of Ecotourism in the Country and create synergies amongst the Central and State Governments, Local communities, conservation NGOs and the private sector for the development of Ecotourism in the country, Ministry of Tourism (MoT) has formulated a National Strategy for Eco-Tourism. A National Board for Sustainable Tourism has also been constituted under the chairpersonship of Secretary (Tourism), comprising of representatives from identified Central Ministries/ organizations, State Governments/ Union Territory Administrations and Industry Stakeholders to guide the operationalisation and implementation of various strategic initiatives for development of sustainable tourism and Eco-tourism in the Country.

MoT under Swadesh Darshan Scheme '(SDS)' has sanctioned 76 projects for development of tourism infrastructure in the Country under various themes including Eco-theme. The list of projects sanctioned under Eco-theme of SDS by MoT is annexed. The Ministry has also sanctioned one project, 'Development of Anandpur Sahib - Fatehgarh Sahib - Chamkaur Sahib - Ferozpur - Amritsar - Khatkar Kalan – Kalanour – Patiala' for Rs.94.51 Crore under heritage theme of Swadseh Darshan Scheme.

The Ministry has now revamped its Swadesh Darshan scheme as Swadesh Darshan 2.0 (SD2.0) with the objective to develop sustainable and responsible tourism destinations, following a tourist & destination centric approach. Kapurthala in Punjab has been selected as one of the destination for development under SD2.0.
